032/2016. A308 Holyport Widening Scheme

Cllr Elvin explained the proposals that RBWM had consulted on regarding the A308 at Holyport.

The first was that there should be a trial no right turn from the A308 into the Upper Bray Road and the implications regarding this were discussed. Cllr Elvin proposed that the trial should not take place. The vote for this was 12 in favour of no ban and one against.

The second consultation regarded modifications to the north side of the A308 carriageway. Cllr Elvin proposed that along with the proposed modifications the Upper Bray Road also be widened at the junction with the A308 and this proposal was discussed. The vote for Cllr Elvin's proposal was 11 in favour, 1 against and 1 abstention.

033/2016.COUNCILLORS' FORUM AND CORRESPONDENCE

Cllr Wilson advised that the Kimber's Lane public enquiry is expected to reach a decision in the next 6 weeks.

Cllr Kneen asked about action being taken regarding the trees that have been cut down at the real Tennis Club, Cllr Wilson replied that there is currently no update.

Cllr Elvin provided an update about Tithe Barn Drive; the RBWM enforcement officer has advised the owner that a revised planning application must be submitted.

Cllr Kneen reminded Councillors that Devolution training needs to take place which will be on a Saturday, Councillors are happy to attend and two alternative dates are to be requested.
