#### 006/2017. REPORT ON ENFORCEMENT MATTERS WITHIN THE PARISH

The Enforcement Report as at Appendix B had been circulated at the meeting. Cllr's agreed to close the enforcement case at Brayfields Stables.

Cllr Elvin raised concerns about the length of time the Enforcement Team at RBWM are taking to update BPC on enforcement cases within the Parish. Cllr Graham proposed he and Cllr Elvin meet with the Clerk to help with the wording of a letter which can then be sent to RBWM highlighting our concerns. Cllr Kneen seconded the proposal. A vote was taken with 9 in favour, 2 abstained and 0 against.

#### 007/2017.COUNCILLORS' FORUM AND CORRESPONDENCE

Cllr Wilson gave an update on Braywick Park Car Park following his site meeting with the contractors. Cllr Wilson confirmed the tradesmen will only use a few spaces and not the whole carpark.

Cllr Wilson informed the meeting he had recently spoke to Maidenhead Waterways Group concerning The Cut and they are willing to give a presentation to BPC on the project. Cllr Wilson will ask them to contact the Parish Office to arrange a date.

Cllr Graham requested the BPC action list becomes an item on the agenda.

Cllr Airey gave an update on the application at Windsor Garden Centre. The application was refused at DCP and the applicant has now appealed. There is no date for the appeal hearing. Cllr Airey will keep BPC updated with any further developments.
