138/2016.COUNCILLORS' FORUM AND CORRESPONDENCE

Cllr Janikoun raised an issue with the agenda now having a cut-off date for members of the public to speak at a planning meeting. He stated this should have been discussed at the main councillors meeting and it may be a change to the standing orders. Cllr Kneen said she will look into this, check the rules, the standing orders and report back at either the main council meeting or at the next councillor's forum to see if a vote is required.

The Assistant Clerk gave a brief update on the recent meeting with Victoria Gibson from RBWM Planning Department.

Cllr Kneen gave an update on the current situation concerning BPC Planning Sub-Committee. There had been some feedback on the actual contract with RBWM which will be raised with Jenifer Jackson. Cllr Kneen met with The Clerk and it was suggested that the standing orders be looked at to check they matched with RBWM. A meeting will be arranged between Cllr Elvin, Cllr Airey, Cllr Graham and Cllr Kneen to go through the contract and the standing orders. BPC needs to ensure the contract is right before it comes back for approval and is voted on.

Cllr Dudley asked if there was a date to go live. Cllr Kneen hopes this will be in the autumn. Cllr Burbage challenged Cllr Kneen claiming the process was being held up which was denied by Cllr Kneen who reiterated her comments regarding the contract as well as the outstanding training requirements for Cllr Dudley and Cllr Janikoun. She asked both Cllr's to confirm dates they would be available so she can arrange the relevant training with Jenifer Jackson. Cllr Elvin also reiterated that we are unable to give a date due to actions outstanding with RBWM.
